



That the school is being run as a community service and not as a business and that 3.

commercialization does not take place in the school in any manner whatsoever.

That no part of the Income from the Trust or School is being and will be diverted to any 4. individual in the trust or School Management Committee or to any other person/entity. The savings, if any, after meeting the recurring and no-recurring expenditure and contributions to developmental, Depreciation and contingency funds will be further utilized for promoting the school and extending the cause of education in the same school only.

That school is not paying any charges towards using name, motto, logo or any other 5.

That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII 6.

That the Principal and Manager of the school have individually gone through the provisions 7. contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and law of the land.
